Milieu Clinician (10/2020 - Present) | Prescribing Practitioner (10/2021- Present):

- A Milieu Clinician provides culturally sensitive, therapeutic services to students in a milieu setting, all while developing comprehensive assessments plans (CAST reports) for faculty, referrals, families, and administration.
- Facilitate individual, family, and group treatment based on treatment plan description.
- Assure residential staff adhere to the appropriate programming and treatment plans for the individual.

- Updated, scheduled, and lead Individual Treatment Plan (ITP) meetings with families and referral sources.
- Co-lead adventure group therapy such as mountain biking in the woods, identity developments groups, social emotional learning groups, faculty and student yoga and mindfulness groups, as well as independent living groups.
- Collaborated with externals for case management needs such as court, family therapy within the home, as well as helped students get to medical appointments.
- Participated in Clinical On-call rotation for one week every 4-5 weeks, as well as participated in 24/7 on-call support for family visits, family travel, and family crisis. This on-call supported the milieu and family either via phone or in person depending on the level of support needed.
